ENERGY AND ATMOSPHERE

EA CREDIT: OPTIMIZE ENERGY PERFORMANCE

1-24 Points

This credit applies to:

MATERIALS AND RESOURCES

MR CREDIT: CONSTRUCTION AND DEMOLITION WASTE MANAGEMENT

1 Point

ZONA® Glass Wall Systems produce less waste than traditional drywall construction thereby significantly reducing the amount of debris diverted to landfills. ZONA's packing materials are recyclable.
